WHEREAS, the partnership agreements have proven to be excellent venues to enable the partner Local Government units to share and exchange best practice, innovations, and success stories, which can be replicated, adopted, or even improved by either partner;

WHEREAS, the City Government of Taguig, being a member of the Philippine International Sisterhood Association (PHISTA), Inc., recognizes the need and significance to establish sisterhood relationships with other local government units, both locally and abroad;

WHEREAS, the City Government of Taguig welcomes the desire of the Municipal Government of Tinambac to establish a Sisterhood Relationship with the City of Taguig as signified in the **Municipality of Tinambac Sangguniang Bayan Resolution No. 17-030** entitled: "RESOLUTION ESTABLISHING A SISTERHOOD RELATIONSHIP BETWEEN THE CITY OF TAGUIG AND MUNICIPALITY OF TINAMBAC, CAMARINES SUR AND FURTHER AUTHORIZING THE HONORABLE MAYOR ATTY.
